Are you up to date on the latest environmental regulations and local land use plans that will apply to infrastructure projects?

These are a few of the urgent questions setting the stage for a dynamic discussion at BPC's 22nd Annual San Francisco Bay Decisionmakers Conference (DMC) on "Sustainability Strategies for a Changing Bay".

Today, we are confronted with unprecedented challenges in the economy and the environment that demand our immediate attention as well as thoughtful planning and prudent action. The Federal economic stimulus program for infrastructure development has great potential for helping to ease California and the Bay region out of recession. Concurrently there is the overlay of global warming and climate change threatening the stability of our human and natural ecosystem. As never before, the success of the stimulus program, combined with actions to strengthen California's economy and address climate change, depends on leadership and collaboration to ensure efficient and effective program delivery. This covers recommendations for environmental permitting, contracting procedures and innovative planning criteria at the water's edge.

The DMC's three panels are structured to weave together the components of a sustainable future for the Bay-Delta's region industry, recreation and natural environment; Panel 1. the immediate economic conditions and new federal stimulus funding; Panel 2. the ever-increasing and ongoing environmental permitting challenges and opportunities; and 3) the revitalization of the waterfront based on new synergies among water-dependent industry, transportation, recreation, environmental, residential and commercial uses.

Panel 2 – SECURING PROJECT APPROVAL: WHAT YOU NEED TO KNOW

We have a conundrum. Confronted with a major recession, simultaneously the public is faced with the enormous challenge of an ever-increasing stringent and complex web of environmental regulations. The California Air Resources Board has adopted the most aggressive regulatory program in the nation aimed at cleaning up diesel particulates and reducing greenhouse gas emissions. The state and federal wildlife agencies are increasing endangered species protection. BCDC has analyzed the vulnerability of the region to sea

level rise as a result of climate change and is recommending adaptation strategies. Under new state legislative mandates, local governments are implementing new land use plans and zoning which present both conflicts as well as opportunities. On this panel, representatives from ports, industry and local, state and federal agencies will discuss permit processing issues and ways to see light at the end of the tunnel.
